Romanian Localization – general considerations

Romanian Localization is an add-on to the standard Infor ERP LN product, meant to fulfill Romanian law requirements, as well as specific local business practice requirements. In developing the localization, the general guiding rules were to build it “around” the standard software, not customizing it, in order to keep it as much as possible independent of the ERP LN updates. However, there have been cases (very few, included in the below description) where modifying the standard was needed.

The localization has been structured following the standard LN packages and modules structure. Hence, it includes:

- Common data Romanian localization
- Finance Romanian localization
- Warehouse management Romanian localization

1. Romanian Localization – Common data

1.1. Currency rates

The module includes several sessions for an easy update of the daily currency rates, for:

- Reporting currencies (**Maintain multicurrency rates – daily – tcitccurs**)

- Other currencies (**Maintain multicurrency rates – special currencies - tcitccurs2**)

- Importing the rates from the National Bank of Romania website (**Get BNR currency rates - tcitccursbnr**)

1.2. Business partners

The module includes a session for easy update of new business partners, as well as a session to verify the BPs' CIF codes:

- Update business partners (tcitc4201m000)

The 'Update business partner' window is a standard Windows-style application window. It features a blue title bar with the text 'Update business partner'. 2. Romanian Localization – Finance

2.1. General ledger

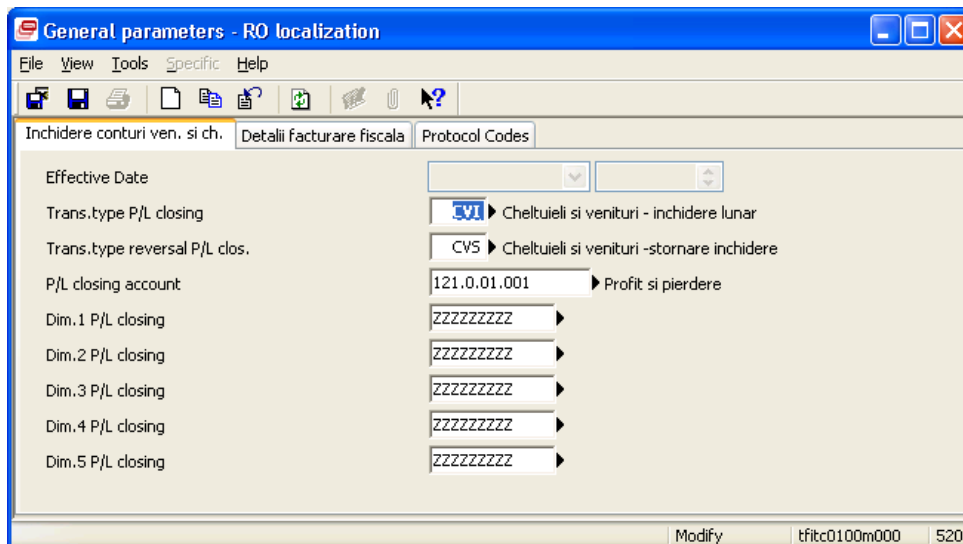
The General ledger localization consists of the following submodules:

- Localization parameters
- Trial balance
- Chess master ledger
- VAT reports
- Localization maintenance
- Special sessions
- Periodic processing
- Generate additional entries for finalized transactions
- Reconciliation
- Import transaction schedule details
- Reports

2.1.1. Localization parameters

This submodule includes a series of parameters used throughout the entire Finance localization:

- **General parameters – RO localization (tfitc0100m000)**
 - This is the place where general localization parameters are maintained:
 - parameters for the monthly balancing of Profit & Loss accounts
 - parameters for generation of fiscal invoices/receipts (the user specifies whether pre-printed forms are used or a “fiscal” number must be generated for the specified documents)



- **Parameters for the monthly closing of VAT accounts (tfitc9197m000)**

- **Various parameters for supporting the functionality of ledger accounts correspondance by document (tfitc9199m000)** (RO: "Correspondenta conturilor la nivel de document"), which is not a standard functionality

- o Besides processing the documents to determine the corresponding D = C entries, it is also possible to opt for compressing the finalized transactions resulted from integration transactions, once they are processed in the localization.
- **Maintain finance super-user password (tfitc9198m000)**

- o The password set up in this session will then be used in several correction sessions that are quite sensitive and should only be run by authorized users.
- **Transaction types for D/C adjustments (tfitc2188m000)**

- In some cases, integration transactions and some other finance transactions may generate the accounting entries using ledger accounts on the “wrong” side (for example cost account on the Credit instead of Debit). To “clean” the trial balance values at the end of month, the localization includes a session which searches for amounts “wrongly” posted and moves them on the correct side of the journal entry. In the parameters session, a transaction type for generating the correction entries is specified, as well as another one – for possible reversals.
- **Maintain employees signing documents – (tfitc9195m000)** for the administration of signatures that must appear on the monthly accounting declarations (like :Trial Balance, VAT Journals, etc)

2.1.2. Chart of accounts

Several new fields have been added to the standard chart of accounts table, in order to support Romanian localization needs.

- *Bifunctional account* – this determines on which column of the trial balance(*) the opening and closing balances of the ledger accounts will be printed:
 - For non-bifunctional ledger accounts, the Debit/Credit setup determines the column – if the ledger account is set up as Debit, then its opening and closing balance will be printed on the Debit columns of the trial balance, regardless of the sign of the values (and similarly for the credit).
 - For the bifunctional ledger accounts, a positive balance will be printed in the Debit columns, while a negative balance will be printed on the Credit columns, sign switched.
- (*) The Romanian format of the trial balance includes separate columns for the Debit and Credit in the opening and closing balance (while the standard is printing all values in a single column – Debits with a plus, Credits with a minus sign).
- *Debit / Credit amounts control* – this field determines if the ledger account requires the values to be positioned on a particular “side” during the month-end processes.
 - Not checked – the ledger account does not require D/C amounts control. No processing of the monthly values is done.
 - Checked – the ledger account is marked for D/C amounts control. This may be required in several cases, such as price differences ledger accounts. There are standard integration transactions which are posting values on the purchase price difference ledger account, but on the Credit side. Normally, price variances resulted from purchase transactions are expected to be posted on the Debit. If D/C amounts control is enabled, then localized session **Repair D/C amounts of ledger accounts (tfitcreg1)** may be used to move the values posted during the month from the

“wrong” to the “correct” side. In our example, any Credit value on the purchase price differences account would generate a journal entry in the format:

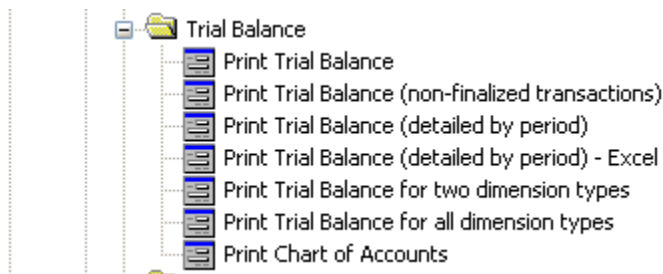
- Price diff. ledger account = Price diff. ledger account (-) Amount

This way, the value posted on the Credit is moved on the Debit with a minus sign.

- *Debit / Credit adjustment sequence* – this field is enabled for the ledger accounts marked for D/C amounts control (previous field checked). It determines the moment when the D/C adjustment may be performed in session **Repair D/C amounts of ledger accounts (tfiteg1)**. For example, it may be required to process the price differences ledger accounts first, then run cost calculation and only afterwards process the cost and revenues ledger accounts as well. This may be done by setting up different debit / credit adjustment sequences for the two ledger account types. Each sequence may be then processed independently in session **Repair D/C amounts of ledger accounts (tfiteg1)**, whenever it is needed.

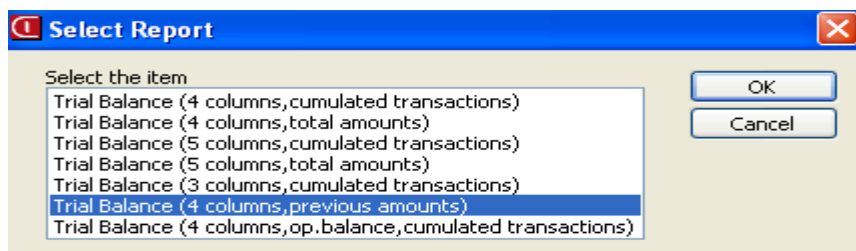
2.1.3. Trial balance

The submodule includes several ‘trial balance’ reports – variants of the classical Trial Balance. The difference is that it prints the ledger accounts’ closing balance on different columns (Debit/Credit) depending on the account type (Debit, Credit or “Bifunctional”).



- **Trial Balance (Ro: Balanta de verificare) (tfitebver)**

The trial balance variants are:



- *4 columns, cumulated transactions*; the columns are:
 - “Transactions for previous periods”
 - “Transactions for current period”
 - “Cumulated transactions” = “Transactions for previous periods” + “Transactions for current period”
 - “Closing Balance”
- *4 columns, total amounts*; the columns are:
 - “Transactions for previous periods”
 - “Transactions for current period”
 - “Total amounts” column = “Opening Balance” + “Transactions for previous periods” +

- "Transactions for current period"
 - "Closing Balance"
- *5 columns, cumulated transactions*; the columns are:
 - "Opening balance"
 - "Transactions for previous periods"
 - "Transactions for current period"
 - "Cumulated transactions" = "Transactions for previous periods" + "Transactions for current period"
 - "Closing Balance"
- *5 columns, total amounts*; the columns are:
 - "Opening balance"
 - "Transactions for previous periods"
 - "Transactions for current period"
 - "Total amounts" column = "Opening Balance" + "Transactions for previous periods" + "Transactions for current period"
 - "Closing Balance"
- *3 columns, cumulated transactions*; the columns are:
 - "Opening balance"
 - "Cumulated transactions" = "Transactions for previous periods" + "Transactions for current period"
 - "Closing Balance"
- *4 columns, previous amount*; the columns are:
 - "Transactions for previous periods"
 - "Transactions for current periods"
 - "Total amounts" column = "Transactions for previous periods" + "Transactions for current periods"
 - "Closing Balance"
- *4 columns, Opening balance, cumulated transactions*; the columns are:
 - "Opening balance"
 - "Transactions for current period"
 - "Total Transactions"
 - "Closing Balance"
- **Trial balance for non-finalized transactions (tfitchbnef)** (In case the "Update mode" for transaction types is "Finalization", the users are still able to print a trial balance for the batches they haven't yet finalized.)

▪ **Print chart of accounts (tfitc0408m000)**

This is a more flexible report on the setup of the chart of accounts, including some basic information (Ledger accounts / Sublevel / Description / Account type / Debit/Credit / Dimensions setup).

▪ **Print dimensions (tfitc0140m000)**

The session prints some basic information on dimensions setup, with an additional option to print the “tree structure” – meaning all parent levels above each dimension (see below an example).

2.1.4. Chess master ledger (RO: Fisa sah)

This module contains the necessary sessions for printing reports of type “Chess master ledger”:

- **Process finalized transactions (tfitctransfer)** – This is the main session used to process finalized transactions in order to obtain the corresponding ledger accounts by document. Depending on the parameters’ setup, after the processing the integration documents may be compressed as well.

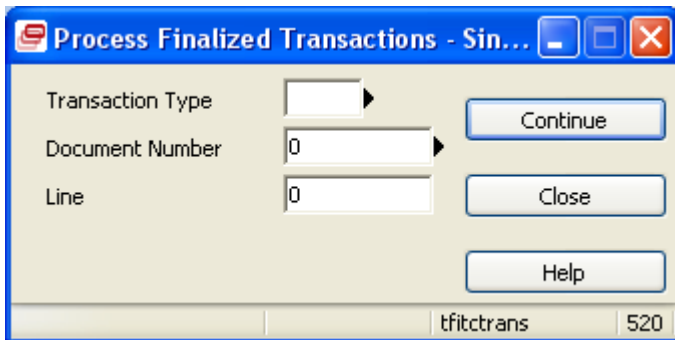

- **Process finalized transactions – single document –(tfitctrans)** this session has the same functionality as the previous one, but it is used when the user wants to process a limited number of finalized documents, as it works faster



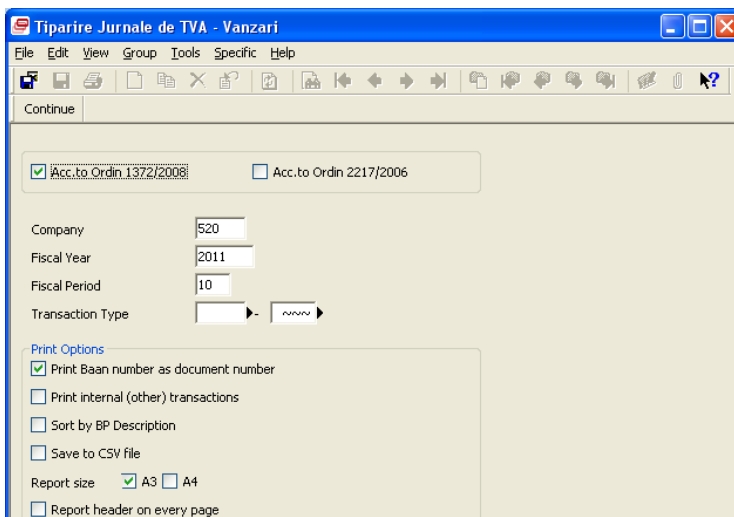
Once the documents have been processed in one of the previous 2 sessions, there are several reports available based on the processed data:

- **Chess master ledger (accounts level = 0) (tfitcc3)**
- **Chess master ledger (accounts level > 0) (tfitcc2)**
- **Chess master ledger (accounts level = 0, detailed by period)(tfitcc3)**
- **Chess master ledger (accounts level > 0, detailed by period) (tfitcc4)**
- **Print ledger accounts transactions sheet (tfitcc7) (RO: Fisa de cont)**
- **Print periodical journal report (tfitcc8) (RO: Raport jurnal)**

2.1.5. VAT Reports

Both the sales and the purchase VAT reports are based on setting up the columns to be printed and the tax codes to be included in the standard Taxation sessions **Tax positions (tfgld0120m000)** and **Relations by tax position (tfgld0521m000)**. Based on the setup, the following two reports are available:

- **Print Sales Journal (Ro: Jurnal de vanzari) (tfitcjrva3)**



The report may be printed either on A3 or on A4 (depending on the number o columns). The format included in the localization is based on the one used by several of our customers, but, since the law does not require anymore a specific format, it may be easily customized according to each company's needs.

Besides printing the report, the session also checks if there are documents for which the VAT code has not been correctly set up in **Relations by tax position (tfgld0521m000)** session and it prints an exception report for those documents.

▪ **Print Purchase journal (Ro: Jurnal de cumparari) (tfjtcjrtva4)**

The details on the purchase journal are very similar to the ones on sales journal.

Besides the 2 VAT journals, the **VAT reports** module also includes a submodule dedicated to generating the biannual VAT report for domestic transactions (RO: Declaratia 394).

The submodule includes a parameters session, to determine the criteria used for excluding documents from being printed in the report. The criteria used may be one or more of the following:

- Transaction type
- VAT code
- Specific documents to be excluded
- Specific documents to be included

Based on the parameters, the reporting session **Biannual VAT report (tfjctvaseme)** prints either a detailed or summary report of the domestic VAT transactions, or it can generate the ASCII file to be imported in the fiscal authorities' application.

2.1.6. Special sessions

The “special” sessions are corrections sessions to be run occasionally and by designated users (most of them are password protected).

- **Delete Finance Document (tfitcstergere)** – the session is used to delete finalized financial documents under certain conditions (The session checks and only allows deletion of documents with transaction type of “Journal voucher” category and which are NOT integration transactions.) If the document had been also processed in the localization to determine the corresponding ledger accounts by document, it will be deleted from the localized tables as well. This session must be followed by a rebuild of ledger/dimension history for the document’s period.

- **Reverse Finance Document (tfitscstornare)** – this session is used to reverse a finalized document; the document's transaction type must be of "Journal voucher" category. The user may choose the way the document will be reversed:
 - "in black" (Ro: "stornare in negru") – meaning that the accounts of the journal entry switch positions (from Debit to Credit and viceversa) and the amount remains the same
 - "in red" (Ro: "stornare in rosu") – meaning that the accounts of the journal entry keep their positions, but the amount's sign is switched
 - "copy document" – meaning that the document is not reversed, but an identical entry is created for the "Document date" specified by the user

2.2. Accounts Receivable Romanian Localization

The module includes several reports:

- **Print detailed customer transactions analysis (tfitcbalc) (RO: Balanta analitica pentru clienti)** – The report is used for tracking customer transactions (sales invoices and all related receipts, advances, etc.) and for reconciling them with the general ledger transactions.

- **Print detailed report by ledger account and business partner (tfitcccontrol)** – The report prints transaction details for the ledger accounts for which Business partner tracking is implemented.

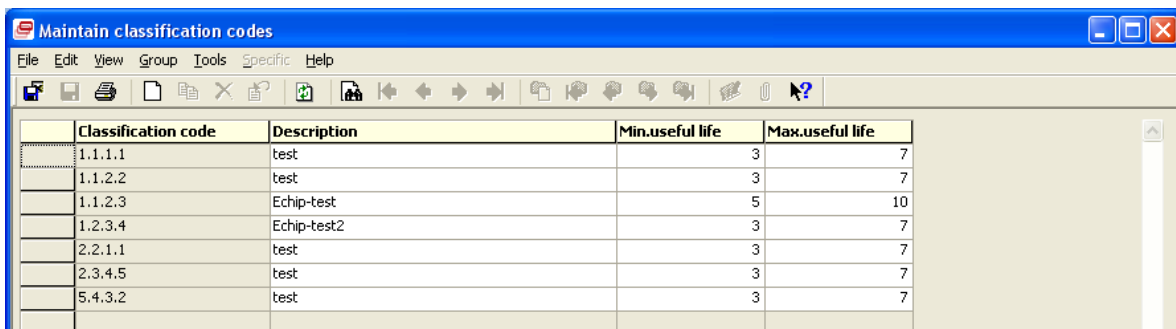

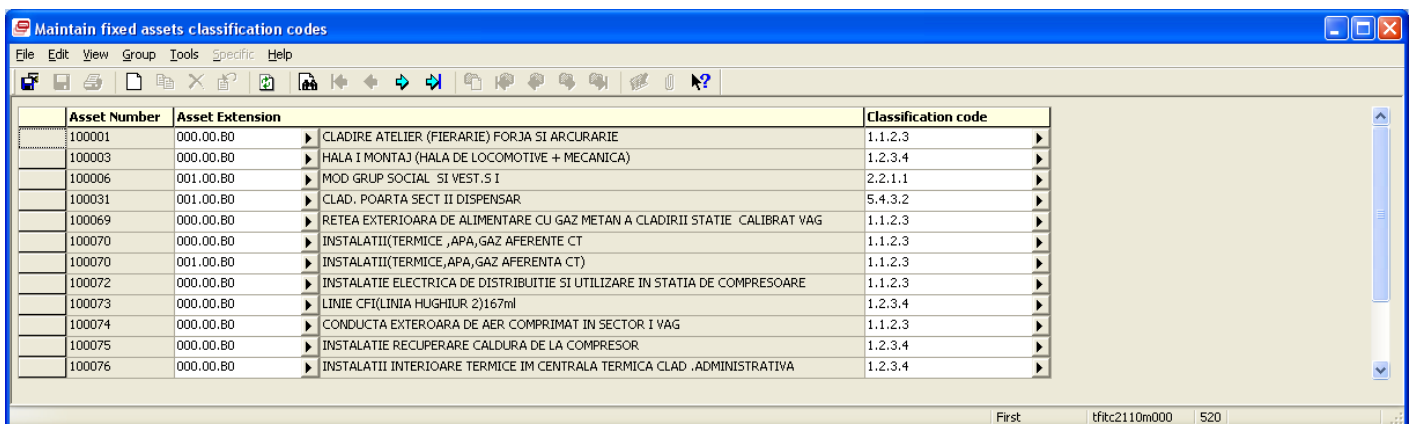

2.5. Controlling Romanian Localization

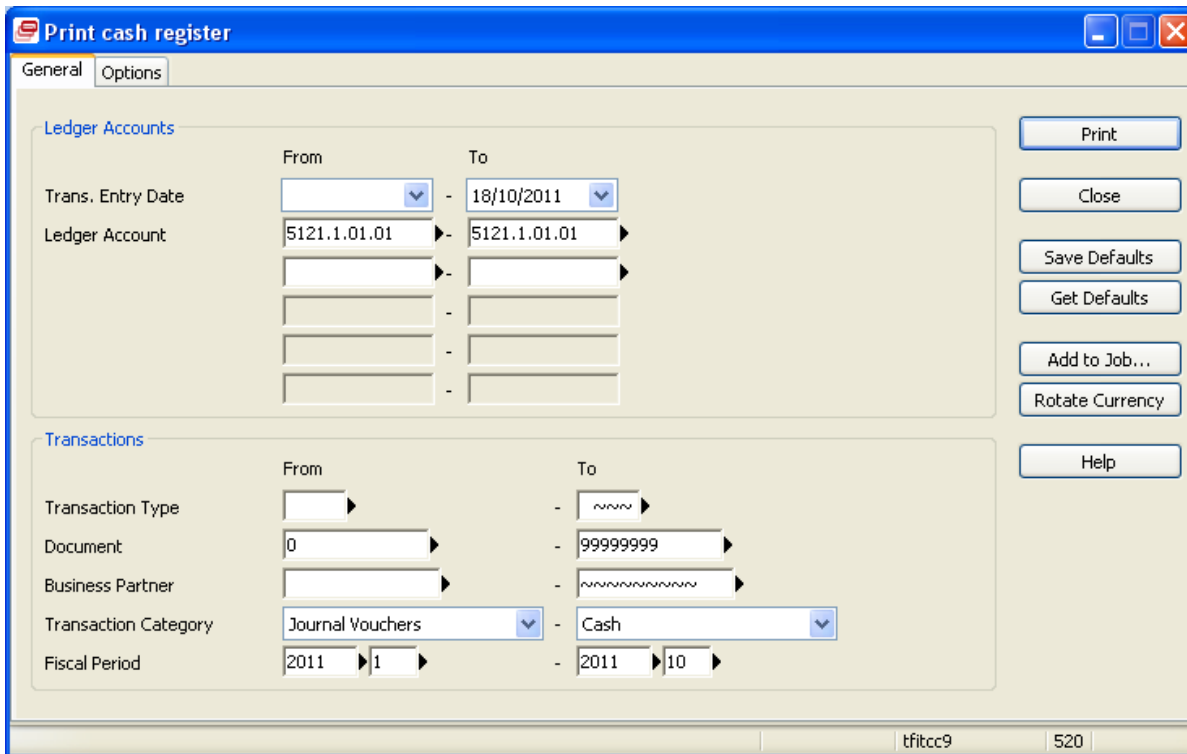

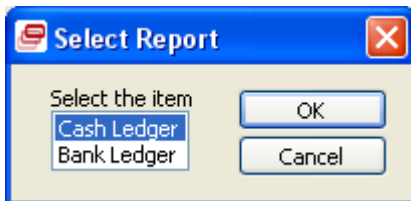

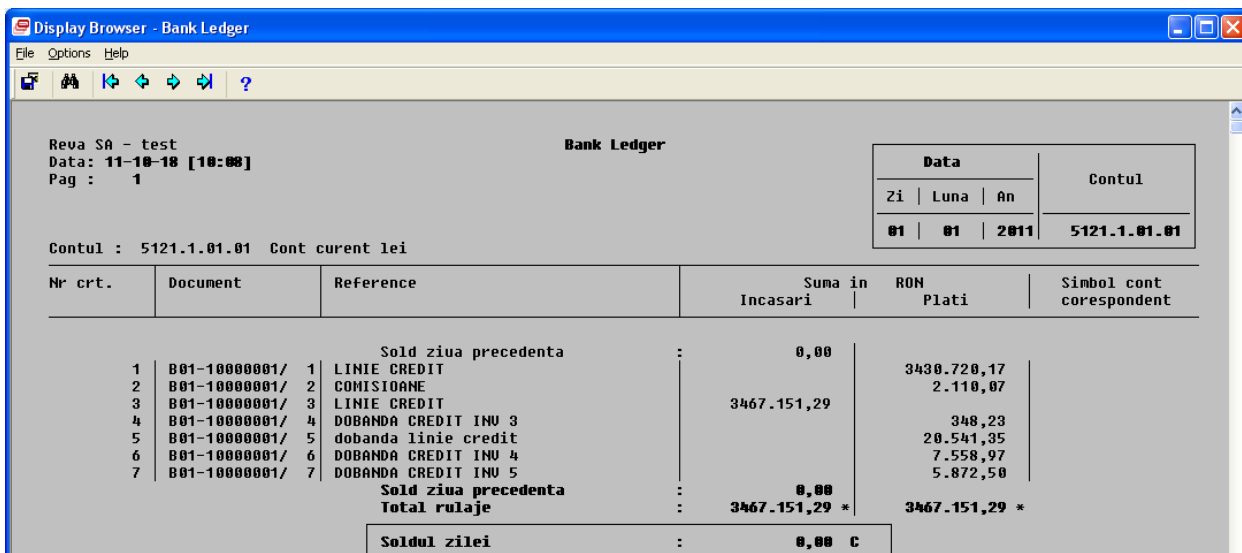

3.2. Intrastat statement

The submodule includes sessions needed to be run in order to obtain the Intrastat statement. The sessions are:
